## **Senate Indian Affairs Committee**

## **Business Meeting to Consider Several Bills**

## 5 March 2025

**Summary:** The committee took action on more than 20 bills, which covered a number of issue areas impacting Tribal nations and citizens. As far as Tribal agriculture and nutrition-related issues, two bills may be of relevance:

## Highlights:

- <u>S.620</u>, Veterinary Services to Improve Public Health in Rural Communities Act sponsored by Sen. Murkowski, the legislation seeks to provide public health veterinary services to Indian Tribes and Tribal organizations, specifically focusing on rabies prevention.
- <u>S.719</u>, Tribal Forest Protection Act Amendments Act of 2025, also sponsored by Sen. Murkowski, seeks to improve the Tribal Forest Protection Act through improved definitions and specifics of the lands impacted.

<u>Sen. Lisa Murkowski</u> (R-AK) discussed the progress of several bills important to Native communities, covering public health, safety, forestry, and water rights. She emphasized the significance of Indian water rights settlements, which provide safe, reliable water supplies and improve public health and economic growth. However, these settlements are costly due to the infrastructure needed. SEN. Murkowski also highlighted legislation on Tribal forestry, public health veterinary services, and a commission on Indian boarding school policies.

<u>Sen. Brian Schatz</u> (D-HI) and <u>Sen. Catherine Cortez Masto</u> (D-NV) also made brief remarks supporting the bills and the bipartisan efforts to address issues in Indian country. The Committee then proceeded to adopt the agenda items unanimously.
